Proof of identity

Only required when an applicant is requesting information on their own behalf.

When seeking access to personal information, an applicant must provide proof of identity in the form of any one of the following documents:

- Australian driver's license (with photograph, signature and current address)
- Current Australian passport
- Other proof of signature and current address details

If mailing the application: provide a certified copy of the proof of identity means that your proof of identity must be verified (that is, signed and dated) by an authorised person (Justice of the Peace, doctor, teacher, pharmacist, legal practitioner, Postmaster - Australia Post).

Application fee and processing charges

- money order (enclose a money order made payable to Service NSW)
- Cash (can be made at Service NSW Service Centres - do not send cash by post)
